Terms and Conditions

1. Tuff Gong International (TGI) is the sole owner of the "TGI Muralist Competition" and ALL products, services or promotions related to or arising from the TGI Muralist Competition.
2. The TGI Muralist Competition is open to individuals, amateur and professional living in Jamaica.
3. The TGI Muralist Competition is open to individuals aged 17 years or older. Individuals must have attained the age of 17 on or before July 11, 2013 to be eligible.
4. Entry for all individuals is free of cost.
5. Multiple entries by an individual are allowed.
6. Submissions must be completed by the entrants and must be their original production. Submissions found to be copies, reproductions or selection.
7. All submissions must be previously unsold and unpublished
8. The judges will accept submissions in any form, including photography, film and electronically created images.
9. Entries must portray the themes of Unity, Love, Hope, Endurance, Creativity and Diversity inspired by any music created by Bob Marley, Rita Marley, any Jamaican born Tuff Gong International Recording Artistes, Ziggy Marley, Ziggy Marley and the Melody Makers, Stephen Marley, Julian Marley, Kymani Marley, and/or Damian Jr. Gong Marley.
10. Entries may be submitted between June 24, 2013 and July 20, 2013.
11. No submission will be accepted after July 20, 2013.
12. The successful submissions will be reproduced large scale on a 10X8 concrete structure at 220 Marcus Garvey Drive, Kingston 11, where it will be open to public viewing by the visitors, guests and customers of TGI.
13. Images of the successful submissions, their reproductions, the successful entrants and the TGI Muralist Competition generally will be posted on TGI social media platforms and TGI TV.
14. All entrants will retain copyright in the works submitted.
15. By entering the TGI Muralist Competition all entrants agree to grant TGI a non-exclusive license to use their submitted artwork and all images of the submitted artwork for promotion, publicity, marketing, tourism or other related purposes.
16. The TGI Muralist Competition does not grant or include a cash prize of any kind.
17. Entries may be completed and submitted as follows:
 - A) Online at www.tuffgongjamaica.com by completing the online application form and uploading the image of the submitted work.
 - B) By post or other delivery to 220 Marcus Garvey Drive, Kingston 11 of duly completed and signed application form and copy of submitted artwork. We recommend that artwork be submitted in JPEG format on a compact disc or in a photographed image. We do not recommend the submission of original artwork.
18. All entrants understand and agree that they, their work and images of them and their works may be used to promote the TGI Muralist Competition on the TGI website and through other media outlets.
19. All selected artists will be notified of the judges' decision at least 48 hours prior to mural reproduction start date.
20. Selected artists will be allowed a minimum period of 7 days to complete mural reproduction
21. TGI will provide all material needed to complete mural reproduction
